3. That the name of the Trust shall be Osom Educational Trust and its principal office shall be situated at Guwahati, Assam or at such other place or places as may from time to time be determined by Trustees.

4. That the objects of the Trust shall be as follows:

- (a) To take over completely the Faculty High School, Ambari, Guwahati established by the Oxom Educational Trust, Trustees of which (who are also Settlers of this Trust) have decided to dissolve the Oxom Educational Trust and put the same Trust property under Osom Educational Trust after dissolution so that Osom Educational Trust can maintain and run the Faculty High School by enlarging and enhancing its scope through creating of a permanent school complex with all requisite facilities for all round development of the students.
- (b) To establish, provide, carry on, manage, maintain and or assist in the maintenance of schools and colleges for boys and girls.
- (c) To provide for research work and for the delivery and holding of lectures, demonstrations, exhibitions, public meetings, classes and conferences calculating directly or indirectly to propagate and advance the cause of education.
- (d) To provide for, establish and maintain and run Libraries, Museum, Societies, Lecture Halls and other institutions and to furnish the same with books, reviews, magazines, newspapers and other publications.
- (e) To establish suitable pre-primary, Primary and Medium level schools as feeder schools which will not only give emphasis to learning of mother tongue but will also teach English well as a subject.

- (f) To establish institution to train and prepare students for appearing in All India examination, like I.A.S. and allied services, banking and allied services, executive cadre of commercial organisation etc.
- (g) To establish, support and maintain institutions for promotion of integration amongst various ethnic group and spreading social consciousness amongst people and to produce records, cassettes etc. with social values.
- (h) To establish societies for undertaking enterprises profits of which will be utilised by the Trust in any manner it considering fit and proper towards furtherance of the Trust's objectives.
- (i) To extend help and relief in the form of free distribution of medicine or giving aids or donations in money or kind to institutions, societies, and other bodies or medical relief or for advancement of art and culture and for the overall mental and physical upliftment of the society in general.
- (j) To establish, support and maintain institution or institutions and societies intended to relieve poverty and distress such as Hospitals, Alms-houses, or orphanages, homes for working girls, homes for refugees, homes for disabled and crippled persons and helpless widows.

- (k) To declare and give bonus, gratuities, pensions or other concessions and allowances to persons who are or were in the employment of the Trust or of any institution or institutions maintained and run by the Trust or the families or dependents of such persons.
- (l) To purchase, take on lease or hire or otherwise acquire any estate, land, building, easements or other rights or interests in immovable properties and all kinds of movable properties and to sell with the permission of the Court, let on lease or otherwise dispose of our grant rights over any real property or other properties whatsoever belonging to the Trust.
- (m) To collect, raise and receive subscriptions, donations and gifts in cash or in kind for all or any of the objects and to apply the same in accordance with the conditions, if any, presented by the donors and agreed to by the Trustees not beyond the objects of this Trust.
- (n) To work for all or any other charitable purposes which may benefit the people in general provided always that and it is hereby declared that if any one or more of the objects specified above are held not to be for public charity, the Trustees shall not carry out such objects as if the same are not incorporated in these presents, but the validity of the Trust created by these presents as a Trust for charitable purposes shall not be affected in any manner.
- (o) To borrow or raise money with or without security and on such terms and conditions as the Trustee may think fit and proper for the purposes of the Trust.

5. 7. That the number of Trustees shall not be less than 5 and more than 11. If the number of Trustees shall fall below 5, the Trustees shall not, except for the purpose of filling up the vacancy, act so long as the number is below the said minimum.

8. That the normal tenure of the Managing Trustee shall be for a period of 5 years. Sri P.K.Bhuyan shall be the first Managing Trustee of the Trust.

9. That the Trustees shall elect a Secretary from amongst themselves or through appointment on such terms as they consider expedient and proper.

10. That the Trustees shall meet atleast twice in one Calendar year.

That notice of the meeting of the Trustees shall be given to the Trustees at least one month before the date of the meeting. However, in emergent circumstance the meeting may be held as the Managing Trustee may deem expedient and necessary.

11. That the meetings of the Trust shall be conducted by the Chairman to be elected for each meeting.

12. That notice of the meeting of the Trustees and all others communications may be sent to the Trustees at their address registered for the time being in the records of the Trust.

14. That one-Third of the total number of Trustees shall form the quorum for the meetings of the Trustees.

15. That if within half an hour of the time specified for the meeting called, no quorum is formed, the meeting shall be adjourned to such time and place as the Trustees present may decide and notice of such adjournment shall be given to all the Trustees. In such an adjourned meeting even if no quorum is formed, the Trustees who are present may transact the business for which the meeting was called.

16. That all the questions arising at the meeting of the Trustees shall be decided by a majority of votes and in case of a tie, the Managing Trustee shall have a second or casting vote.

17. That a Trustee who is unable to be present at a meeting of the Trustees because of his absence from the headquarters of the Trust may send his views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matters concerned.

18. That minutes of the proceedings of every meeting of the Trustees shall be entered in a Minute Book to be kept for this purpose and shall be signed by the Chairman of such meetings or of the following meeting and such minutes shall constitute conclusive evidence of the business and other matters transacted at such meetings.

19. That the Trustees shall be entitled to frame rules, add to, modify and or alter the same from time to time as the circumstances may requires for regulating their meetings and proper administration of the Trust.

20. That the Secretary shall have the custody of these presents and of the books of accounts, Minute Book and other documents and or records of the Trust which shall at all times be open to inspection by any of the Trustees.

21. That the Trustees may appointed a Committee or Committees or Sub-Committees consisting of such person or persons whether member of their body or not as they may from time to time think fit for any of the purpose of the Trust and may frame rules relating thereto and may from time to time add to and vary the same as they shall think fit.

That should any differences of opinion exist at any time between the Trustees for the time being in relation to the management or administration or commission of any act or otherwise, however, in the execution of the Trust of these presents, the opinion of the majority of such Trustees shall prevail, provided that in the event of a tie between them, the Managing Trustee shall have a casting vote in addition to his own.

29. That a Trustee may resign office or retire as Trustee by giving one month's notice in writing to his co-trustees.

30. That a person shall cease to be a Trustee under any of the following circumstances :

- (a) if he dies;
- (b) if he without leave of absence does not attend three consecutive meetings of the Trustees;
- (c) if he is adjudged an involvent or is found to be lunatic or of unsound mind by a Court of competent jurisdiction;
- (d) if he is convicted of a criminal offence involving moral turpitude;
- (e) if he resigns his office;
- (f) if he goes to reside out of India for more than two years, or;
- (g) if he is required to resign his office by all the remaining Trustees.

31. That the receipts given by the Trustee for any money paid or any property transferred or delivered to the Trustees by virtue of these presents or in the execution of the Trusts hereof shall effectually discharge the person or persons paying, delivering or transferring the same there from and from being bound to see the application or being answerable to the application or misapplication thereof.

However, if the Trustees accept any donation with conditions attached to it, they shall carry out the same, provided however the Trustees shall not enter into any condition contrary to the objects of the Trust.

38. That the Trustees or any one of them shall be entitled at any time or from time to time to delegate all or any of his or their powers, duties and authorities under these presents to a Co-Trustee or Co-Trustees.

39. That the Trustees may join and co-operate with any trust or institution having allied or kindred objects upon such terms as they may think fit but shall not dissolve or amalgamate the Trust with any other trust.

40. That it is hereby expressly declared that no part of the income of the Trust shall be applied for any purpose outside India for any purpose which is not a public Charitable purpose in law and all provisions hereof shall be construed accordingly.

41. That save and except what is provided hereinabove, the provisions of the Indian Trust Act, 1982 shall apply and govern these presents.

In the event of dissolution and/or liquidation of the Trust, the assets of the Trust will be given to some Charitable institution with similar objects.
